## **GRAFFITI ABATEMENT PROGRAM:**

 David Lombardi provided an overview of the Graffiti Abatement Program that is proposed by City Outdoor to deal with the trash and graffiti that accumulates around construction sites within the District boundaries.

### MOTION#2: EXECUTIVE DIRECTOR CONTRACT MANNY GONZALEZ

Upon a properly made and seconded motion it was resolved to approve a resolution of the Wynwood Business Improvement District ("BID") of the City of Miami, Florida to hire Manny Gonzalez as the Executive Director with an employment package that consists of \$104,500 base salary, \$400 monthly car allowance and \$100 cell phone allowance, in addition to the coverage of healthcare costs not to exceed \$650.00 monthly.
