Proposed Legislative Items Summary:

A. Resolution of the Wynwood Business Improvement District "BID" of the City of Miami, to approve the proposed Alcohol and Noise Waiver extension associated with the 30+ Miami Music Week events scheduled to begin March 25th within the Wynwood District boundaries. Resolution to be forwarded to District 5, if approved, for Commission Pocket Item ratification.

Funding Source: None Needed

- **B.** Resolution of the Wynwood Business Improvement District "BID" of the City of Miami, Florida, to approve the revised proposal by City of Miami Police security camera provider, totaling \$31,439.55 for additional antenna installation services that would be required to feed the connection to PD station from Wynwood.
 - ** Please note that the Wynwood BID approved at the November 2018 BID Board meeting the piggy-back purchase of the Wynwood security camera network totaling \$149,600, for a total of (25) forensic day/night cameras, (78) video cameras and (2) license plate readers.

C. Resolution of the Wynwood Business Improvement District "BID" of the City of Miami, Florida, to approve the Easy Grass proposal totaling \$12,075 for the installation 1,500 sq. feet of rubber mulching on 50 tree pits located within the Wynwood District to avoid trip and falls along busy thoroughfares.
